1. GDP Growth Outlook Brightens Amid Easing Iran War Tensions

Contextual Summary

- **Growth Upgrade:** Goldman Sachs upgraded India's CY2026 GDP growth forecast to **6.8%**, following a formal US-Iran peace agreement that eased West Asia geopolitical tensions.
- **Resilient Performance:** India's real GDP expanded by **7.8%** year-on-year in Q1 CY2026, surpassing initial market expectations by 50 basis points due to robust domestic fundamentals.
- **Growth Drivers:** The stronger-than-expected economic performance was primarily driven by resilient investment activity and robust service sector performance.
- **Investment Surge:** Gross Fixed Capital Formation (GFCF) hit a six-quarter high of **10.8%** year-on-year, supported by healthy automobile production and strong capital imports.
- **Exogenous Shock Mitigation:** Government measures insulated consumers from direct energy shocks, limiting the pass-through of volatile global fuel costs to the domestic economy.
- **Volatility Caution:** Economists emphasize that while lower crude prices and eased supply constraints mitigate downside risks, growth remains sensitive to global macroeconomic volatility.

Key Definitions

- **Gross Fixed Capital Formation (GFCF):** A macroeconomic indicator measuring net increase in physical assets (infrastructure, machinery) within an economy, serving as a proxy for investment activity.

- **Exogenous Shocks:** Unexpected external economic events (e.g., geopolitical conflicts, global supply chain disruptions) that originate outside the domestic economy but significantly impact its performance.

2. Anti-Dumping Probe on Steel Imports from China, Japan, and Russia

Contextual Summary

- **Investigation Initiated:** The Directorate General of Trade Remedies (DGTR) has launched an anti-dumping investigation into hot-rolled flat steel products imported from China, Japan, and Russia.
- **Industry Grievance:** Major domestic steelmakers (JSW Steel, Jindal Steel, Tata Steel, and SAIL) filed the application, alleging that a surge of cheap imports has caused severe material injury to local manufacturing.
- **Price Undercutting:** The notification notes that the volume of these imports increased significantly in absolute terms, undercutting, suppressing, and depressing domestic steel prices.
- **Financial Impact:** Despite maintaining high domestic sales volumes, local steel manufacturers reported accumulated inventories, operational losses, and declining returns on capital investments.
- **Demand for Retrospective Duty:** The domestic industry has requested the retrospective imposition of anti-dumping duties, citing a historical pattern of predatory pricing that threatens irreparable harm if left unchecked.



Key Definitions

- **Anti-Dumping Duty (ADD):** A protectionist tariff imposed by a domestic government on foreign imports that it believes are priced below fair market value to prevent unfair competition.
- **Material Injury:** A substantial and demonstrable adverse impact on the financial and operational health (such as profits, output, or market share) of a domestic industry caused by dumped goods.



Constitutional & Legal Provisions

- **Customs Tariff Act, 1975 (Section 9A):** Empowers the Central Government to impose anti-dumping duties upon the determination of dumping and material injury by the investigating authority.
- **Anti-Dumping Rules, 1995:** Provides the statutory framework and procedural guidelines for the DGTR to conduct investigations, calculate dumping margins, and recommend duties.
- **Directorate General of Trade Remedies (DGTR):** The apex national body under the Ministry of Commerce and Industry responsible for administering all trade remedial measures, including anti-dumping, countervailing duties, and safeguard measures.

3. Revamp of Rural Job Scheme: Enhancing Accessibility for Divyangjan

Contextual Summary

- **New Inclusive Vertical:** The government is introducing a specialized vertical for Persons with Disabilities (PwDs) under the VB-GRAM G scheme starting July 1, 2026.
- **Differentiated Schedule of Rates:** A tailored Schedule of Rates (SoR) will align productivity norms with individual capacities, guaranteeing full daily wages (₹241-400) without requiring rigid working hours.
- **Shift in Work Profile:** Eligible workers will be transitioned away from intensive manual labor toward supervisory, support, and livelihood-oriented roles closer to their residences.

- **Target Population:** According to the 2011 Census, India has nearly 26.8 million PwDs, with almost 70% residing in rural areas, necessitating targeted socio-economic intervention.
- **Institutional Tracking:** Special Gramin Rozgar Guarantee Cards will be issued to streamline identification, track statutory entitlements, and systematically allocate appropriate tasks.
- **Financial Allocation:** The Centre has proposed a total allocation of ₹1.51 trillion for VB-GRAM G in FY27, bolstering sustainable asset creation like rural markets and skill centers.

Key Definitions

- **Schedule of Rates (SoR):** A comprehensive matrix detailing the government-approved payment rates for specific quantities of work or industrial output.
- **VB-GRAM G:** A rural infrastructure and employment scheme aligned with the Viksit Bharat 2047 vision, integrating wage employment with asset creation.

4. Spurious Oxytocin Concerns and Maternal Safety Investigations

- **Central Intervention:** The Union Health Ministry has sought a comprehensive report from the Rajasthan government following maternal deaths and severe post-caesarean complications across multiple state-run hospitals.
- **Global Health Alert:** The World Health Organization (WHO) intervened to request information from India to determine whether the risk of spurious oxytocin is localized or indicates a widespread supply-chain vulnerability.



- **Regulatory Enforcement:** Following the fatalities, the Central Drugs Standard Control Organisation (CDSCO) and state authorities cancelled the licenses of a Kota-based distributor and two manufacturing units in Punjab.
- **Clinical Trigger:** The affected patients suffered from severe postpartum hemorrhage (excessive blood loss), pointing directly toward sub-standard or counterfeit uterine-contracting medications.
- **Public Health Risk:** The probe focuses on standardizing the pharmaceutical supply chain to eliminate counterfeit life-saving drugs from public health distribution networks.

Key Definitions

- **Oxytocin:** A critical synthetic hormone administered during childbirth to induce labor, stimulate uterine contractions, and prevent severe postpartum hemorrhage.

5. Cyberspace and Border Vulnerabilities in Drug Trafficking: NCB Report

Contextual Summary

- **Digital Trafficking Shift:** The Narcotics Control Bureau (NCB) Annual Report highlights that encrypted messaging apps like Telegram, WhatsApp, and Signal have emerged as primary channels for global and domestic drug trafficking.



- **Telegram as a Key Hub:** Telegram has specifically become a prominent drug-advertising platform, utilizing public channels to broadcast product listings, pricing, and delivery logistics to vast subscriber bases.
- **Departure from Darknet:** Unlike traditional darknet marketplaces that require specialized software, encrypted messaging apps offer illicit traders a more accessible, user-friendly interface with broad public reach.
- **Geopolitical Border Concerns:** The report flags the Myanmar transit route as a critical geopolitical vulnerability, facilitating the illicit inflow of narcotics into India's northeastern corridor.
- **Institutional Response:** The findings were highlighted by the Union Home Minister at the apex-level meeting of the Narco-Coordination Centre (NCORD) to overhaul multi-agency enforcement strategies.

Key Definitions

- **Encrypted Messaging Platforms:** Applications using cryptographic protocols to secure communications, ensuring that data can only be read by the sender and the designated recipients.

6. Demographic Divergence: Delimitation, Tax Devolution, and Fertility Challenges

Contextual Summary

- **Demographic Projections:** UN Population Division data indicates India's population will likely peak at 170 crore in 2062 and decline thereafter, with the current national Total Fertility Rate (TFR) standing at 1.9.
- **Regional Disparities:** Severe demographic divergence exists between high-fertility northern states like Bihar (TFR 2.9) and Uttar Pradesh (TFR 2.6), and southern states operating well below the replacement level.
- **The Delimitation Dilemma:** Declining fertility in southern states raises political concerns regarding a potential loss of parliamentary representation during future seat realignments based on population.
- **Incentive Policies Pitfalls:** States like Andhra Pradesh have introduced financial and welfare incentives to boost birth rates, but historical global precedents show that one-off material incentives rarely reverse structural demographic declines.
- **Persistent Sex Ratio Distortion:** Despite gradual improvements (918 in 2022-24 from 907 in 2018-20), India faces a persistent "girl deficit" at birth, remaining far below the natural biological standard of 955.
- **Policy Recommendation:** The authors argue against raising fertility rates; instead, they advocate for decoupling political representation and fiscal devolution from pure population metrics to penalize or reward states equitably.

- **Total Fertility Rate (TFR):** The average number of children that would be born to a woman over her lifetime if she were to experience the exact current age-specific fertility rates.

7. Israel-Lebanon Framework Peace Agreement: Geopolitical Realignments

- **Trilateral Agreement Inked:** Israel and Lebanon have signed a milestone framework agreement in Washington, brokered by the United States, to permanently end hostilities between Israel and the Iran-backed Hezbollah militant group.

- **Socio-Economic Rebound:** The cessation of active warfare is expected to alleviate massive displacement crises, which have uprooted over a million civilians and caused severe infrastructure casualties.

- **Big Tech Liabilities:** Digital giants face steep financial penalties of up to 49.5 million Australian dollars (\$34 million USD) if they fail to take verifiable, reasonable steps to remove underage accounts.
- **Global Domino Effect:** Following Australia's world-first legislative precedent, nations like Britain, Canada, Brazil, and Indonesia have introduced or are actively structuring similar age-based social media restrictions.

- **Public Health Mandate:** Governments are increasingly shifting away from laissez-faire tech policies to combat systemic youth harms, such as algorithmic addiction, targeted cyber-bullying, and excessive screen time.

- **Age Assurance Technology:** Technical mechanisms (such as biometrics, database verification, or tokenized IDs) used by digital services to estimate or verify a user's chronological age without compromising data privacy.

9. State-Sponsored Cyber Warfare: The Economic Shock of the Jaguar Land Rover Hack

- **Unprecedented Economic Hit:** An advanced ransomware attack on Jaguar Land Rover (JLR) forced a five-week production shutdown, delivering a massive \$2.5 billion blow to the United Kingdom's broader economy.

- **Sophisticated Malware Delivery:** The adversaries deployed a novel ransomware strain built on unique encryption algorithms, bypassing traditional cyber defense perimeters and causing a highly coordinated industrial paralysis.
