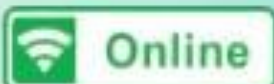
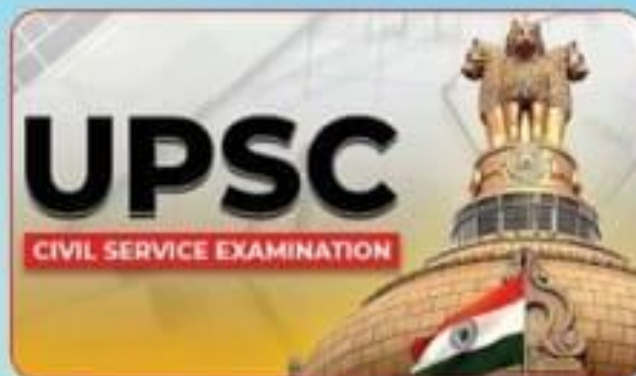

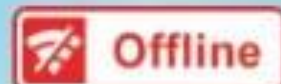

POLITY & CONSTITUTION

1. SC Strength Expansion via Ordinance: Judicial Independence Issues

- **Unprecedented Strength Expansion:** Following the May 2026 Presidential Ordinance lifting the Supreme Court's sanctioned judge strength from 34 to 38, five new judges were sworn in. While two filled regular vacancies, three were appointed to posts existing solely because of the Ordinance.
- **Threat to Judicial Autonomy:** Article 124(1) leaves the determination of Supreme Court strength to Parliament. Appointing judges to temporary offices created via a temporary executive Ordinance compromises the basic structural tenet that the judiciary must remain unguided by obligation to the executive.
- **Contradiction of Legal Precedents:** Accepting appointments to Ordinance-created posts clashes with the Court's own historical jurisprudence. Landmark rulings like *D.C. Wadhwa (1986)* and *Krishna Kumar Singh (2017)* strictly held that executive ordinances cannot act as a parallel source of lawmaking.
- **NJAC Core Principles Bypassed:** In the 2015 *NJAC Case*, a Constitution Bench struck down the 99th Amendment to safeguard judicial primacy in appointments against executive influence. Critics argue that accepting temporary positions holding office at the executive's legislative sufferance dilutes that very protection.
- **The Post-Lapse Legal Anomaly:** If Parliament fails to replace the Ordinance within six weeks of reassembling, the sanctioned strength reverts to 34. This leaves the junior-most judges holding offices no longer legally recognized, placing their tenure security in a precarious structural spot.
- **De Facto Protection and Perceptions:** While the *de facto doctrine* (*Gokaraju Rangaraju, 1981*) protects past rulings made by an affected judge, the subtler harm is to public perception. A judge whose continuation depends on the executive regularizing their seat faces structural hurdles in displaying visible detachment.

Key Terms & Legal Principles

- **Ordinance-Making Power:** Power under Article 123 enabling the President to legislate on the Cabinet's advice when Parliament is not in session. It is an exceptional mechanism, not a permanent substitute for standard legislative process.
- **De Facto Doctrine:** A legal rule validating administrative or judicial acts performed by an official carrying out duties under a defective or later invalidated title, protecting institutional continuity and public interest.

Constitutional Provisions

- **Article 124(1):** Expressly vests the power to alter the Supreme Court's numerical composition in Parliament through legislative amendment.
- **Basic Structure Doctrine:** Establishes that the independence of the judiciary is an unalterable core of the Constitution that cannot be compromised by either executive or legislative maneuvers.

Conclusion

Expanding the bench via an executive shortcut to curb pendency compromises critical safeguards surrounding the security of tenure. To prevent the appearance of political obligation, structural modifications to the apex court must follow regular legislative debate inside Parliament rather than temporary executive decrees.

2. Operationalisation of Arunachal Pradesh Freedom of Religion Act

The High-Powered Draft Rules Committee has submitted its recommendations to the state government, paving the way to operationalise the Arunachal Pradesh Freedom of Religion Act (APFRA), 1978, after nearly five decades.

Key Summary Points

- **Historical Dormancy:** The APFRA was enacted by the state assembly in 1978 and received Presidential assent, but successive state governments left it largely dormant for 48 years by failing to frame its implementation rules.
- **Judicial Intervention:** The activation process was triggered by specific directions from the Itanagar Bench of the Gauhati High Court, which mandated the state government to frame and notify the statutory rules under the Act.
- **High-Powered Committee:** Headed by Justice (Retd) Brojendra Prasad Katakey, the panel conducted extensive consultative exercises with key socio-religious stakeholders to formulate the final draft recommendations.
- **Prohibition of Coercion:** The 1978 parent Act strictly prohibits any religious conversions achieved through force, fraud, or inducement, and sets specific penal punishments for violations.
- **Preservation Mandate:** The primary legislative intent behind operationalising the rules is to legally protect and preserve the indigenous faiths, traditional practices, and nature worship (such as Donyi-Polo) of the state's diverse ethnic tribes.



Definitions & Key Concepts

- **Conversion:** The formal act of renouncing one's native religious faith or tribal custom to adopt another religion.

- **Indigenous Faith:** Traditional religions, beliefs, rituals, and customs native to Arunachal communities, including Donyi-Polo, Mahayana/Theravada Buddhism, and localized forms of Vaishnavism.
- **Inducement:** The offer of any gift, cash, material benefits, or systemic privileges (pecuniary or otherwise) to tempt an individual to alter their faith.

Constitutional & Legal Provisions

- **Article 25(1):** Guarantees freedom of conscience and the right to freely profess, practice, and propagate religion, subject to public order, morality, and health.
- **Rev. Stainislaus v. State of MP (1977):** The Supreme Court ruled that the right to "propagate" does not include the fundamental right to convert another person, validating early state anti-conversion laws.
- **Seventh Schedule (State List - Entry 1):** "Public Order" empowers state legislatures to enact regulations governing religious conversions if they threaten local public tranquility.

Conclusion

The formal submission of the Katakey Committee report marks a critical milestone in Arunachal Pradesh's legal history. Striking a fine balance between safeguarding fragile indigenous tribal identities and ensuring individual constitutional liberties remains central to its final executive notification and implementation.

3. Tenth Schedule and Party Mergers: Interpreting the Anti-Defection Law

- **Context of Controversy:** Recent political friction involving splits within the Trinamool Congress (TMC)—where 20 out of 28 Lok Sabha MPs announced a merger with the Nationalist Citizens Party of India (NCPI) and around 60 MLAs formed a separate faction in West Bengal—has renewed intense focus on the merger exemptions under the Anti-Defection Law.
- **Constitutional Intent:** The Tenth Schedule was enacted via the 52nd Constitutional Amendment Act, 1985, to curb the destabilizing politics of opportunistic defections ("Aaya Ram, Gaya Ram" culture) by disqualifying legislators who voluntarily give up party membership or vote against party whips.
- **Evolution of Merger Exceptions:** Originally, the law protected splits (one-third members breaking away under Paragraph 3) and mergers (two-thirds members joining another party under Paragraph 4). However, the 91st Constitutional Amendment Act, 2003, deleted Paragraph 3, making an institutional merger the only valid path to escape disqualification.
- **The Legal Fiction of Paragraph 4:** For a valid exemption under Paragraph 4, a dual requirement must be met: the "original political party" must decide to merge with another outfit, and cumulatively, not less than two-thirds of the members of the "legislature party" must agree to that merger.
- **Key Concept Definitions:** **Political Party** refers to the entire organizational structure of a party outside the house, registered under the Representation of the People Act, 1951.

Legislature Party comprises the group of elected members representing that political party within a specific legislative house (Parliament or State Assembly).

- **Judicial Directives & Provisions:** In the *Subhash Desai v. Governor of Maharashtra* (2023) case, the Supreme Court re-emphasized that the political party and the legislature party are distinct entities. The Court held that the authority to issue whips and choose leaders vests inherently in the political party, meaning a rebel faction of a legislature party cannot unilaterally declare itself the original party or orchestrate a merger without the parent organization's structural consent.

Conclusion

The strategic bypass of using minor, registered unrecognized parties to house breakaway factions exposes loopholes in the Tenth Schedule. To safeguard the electorate's mandate, structural amendments are required to clarify that legislative numerical strength cannot stand independent of the organizational political party.

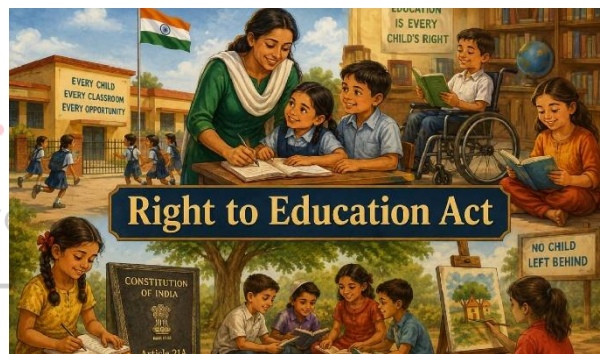
4. Non-Implementation of RTE Act in Punjab: SC Scrutiny

Key Definitions: * **Economically Weaker Sections (EWS):** A category of citizens having an income below a specified threshold, eligible for affirmative action and welfare benefits.

- **Mandamus:** A prerogative writ issued by a superior court commanding a public authority or lower court to perform a mandatory statutory duty.

Core Summary & UPSC Key Points

- **Supreme Court Intervention:** A Supreme Court bench comprising Chief Justice Surya Kant and Justice A. Mohana issued notices to the Centre and the Punjab government regarding a public interest plea alleging non-implementation of the Right to Education (RTE) Act.
- **Failure of Section 12(1)(c):** The petition highlights systemic failure in implementing Section 12(1)(c) of the RTE Act, which mandates private unaided non-minority schools to reserve a minimum of 25% of entry-level seats for children from weaker and disadvantaged groups.
- **Persistent Compliance Gap:** The plea alleges that the non-compliance by Punjab has persisted for 15 years since the Act's inception, demonstrating an institutional failure to operationalize fundamental educational rights.
- **Data Discrepancy:** While the state government reported admitting only 476 EWS children into private-aided schools, data reveals that out of nearly 2 lakh annual entry-level admissions across private schools, the mandatory 25% quota should translate to approximately 50,000 students.



- **Policy Lack on Reimbursement:** The apex court questioned the state's universal policy regarding financial compensation to private schools for hosting EWS students, emphasizing that funding friction shouldn't hinder a child's right to education.

Constitutional & Legal Provisions

- **Article 21A (Fundamental Right):** Mandates the State to provide free and compulsory education to all children aged 6 to 14 years in such manner as the State may determine.
- **Article 45 (Directive Principles):** Urges the State to provide early childhood care and education for all children until they complete the age of six years.
- **Section 12(1)(c) of RTE Act, 2009:** Imposes a statutory social obligation on private unaided educational institutions to provide free education to disadvantaged children, ensuring socioeconomic integration.

Conclusion

The execution deficit of the RTE Act in Punjab reflects a broader national challenge where progressive social legislation stalls at the implementation level. Ensuring compliance requires robust state oversight, transparent independent auditing of private school seats, and a streamlined, timely reimbursement mechanism to prevent private institutions from bottlenecking underprivileged admissions.

5. Ladakh Governance Deadlock: Article 371 & Administrative Control

- **Omissions in Minutes of Meeting (MoM):** Negotiations between the Ministry of Home Affairs (MHA) and Ladakh's civil society leaders hit a standstill. Ladakh leadership refused to sign the MoM from the May 22 talks, citing the exclusion of core agreed-upon administrative and legislative clauses.
- **Control Over Bureaucracy:** The primary point of contention is the omission of a clause giving Ladakh's proposed elected administrative head the authority to review the Annual Performance Appraisal Report (APAR) of the Chief Secretary and influence the transfer and posting of bureaucrats.
- **The Article 371 Alternative:** To address Ladakh's core demands for the Sixth Schedule and full statehood, the MHA proposed a compromise model of self-administration within the Union Territory structure, modeled specifically under sub-articles A, F, and G of Article 371.
- **Demand for Explicit Statutory Guarantees:** Leaders from the Apex Body Leh (ABL) and Kargil Democratic Alliance (KDA) emphasize that an elected head without structural jurisdiction over 'Services' would remain powerless, drawing parallels to governance friction seen in other Union Territories like Delhi.
- **Mobilization for Constitutional Safeguards:** Headed by civil society groups and activists like Sonam Wangchuk, the ongoing agitation seeks robust structural safeguards protecting Ladakh's distinct land, local jobs, cultural identity, alongside an independent Public Service Commission.

Key Definitions & Provisions

- **Article 371 (Special Provisions):** Part XXI of the Constitution contains temporary, transitional, and special provisions for specific states to preserve tribal cultures, address economic backwardness, and maintain local law and order. Sub-articles A, F, and G explicitly safeguard the customary laws and land rights of Nagaland, Sikkim, and Mizoram respectively.
- **Constitutional & Legal Provisions:** Union Territories are governed under **Article 239** and **Article 239A/AA** (where applicable for legislatures). The reorganization of Ladakh into a Union Territory without a legislature was enacted via the **Jammu and Kashmir Reorganisation Act, 2019**, shifting core executive jurisdiction over 'Services' and land directly to the Union via the Lieutenant Governor.

Conclusion

The impasse over Ladakh's governance model highlights the delicate challenge of balancing direct central oversight in sensitive frontier regions with local democratic aspirations. Granting statutory control over the local bureaucracy remains crucial to ensuring meaningful, representative self-governance rather than merely transactional administrative devolution.

6. Waqf Board Composition Controversy: Non-Muslim Nominations

- **Statutory Compliance Mandate:** Legal friction has arisen over the non-inclusion of non-Muslim members in the Kerala State Waqf Board, highlighting the challenge of implementing federal legislative mandates at the state level.
- **The Legislative Trigger:** Section 14(1)(f) of the Waqf (Amendment) Act, 2025 explicitly mandates that two members of a State Waqf Board, excluding ex-officio members, must be non-Muslims.
- **Administrative Evasion by States:** Previous state administrations in Kerala and Tamil Nadu bypassed this provision by appointing only nine Muslim members and leaving the remaining two non-Muslim slots vacant to avoid local communal friction.
- **High Court Legal Challenge:** A writ petition filed in the Kerala High Court contends that the partial constitution of the board deliberately flouted statutory provisions, rendering its administrative and quasi-judicial decisions *null and void* ab initio due to a lack of lawful jurisdiction.
- **Political and Judicial Dilemma:** The Indian Union Muslim League (IUML) and the United Democratic Front (UDF) face a complex situation, as the IUML has simultaneously challenged the constitutional validity of the Waqf (Amendment) Act, 2025 in the Supreme Court.

Key Definitions & Provisions

- **Waqf:** An endowment made by a Muslim to a religious, educational, or charitable cause, which is permanent in nature and legally binds the property to the specified public good.



- **Ab Initio:** A legal term meaning "from the beginning." In judicial reviews, if an administrative body is declared unconstitutional ab initio, all its past official actions and rulings are treated as if they never possessed legal validity.
- **Constitutional & Legal Provisions:** **Article 246** empowers Parliament to enact laws on subjects listed in the Concurrent List (Entry 28: Charities, charitable institutions, charitable and religious endowments). State governments are bound by **Article 256** to ensure compliance with laws made by Parliament. However, religious groups argue that altering board composition infringes upon **Article 26**, which guarantees the freedom of every religious denomination to manage its own affairs in matters of religion.

Conclusion

The dispute underscores the delicate balance between the Union's legislative intent to reform regulatory transparency and the states' management of minority religious sentiments. Resolving the gridlock requires judicial clarity on whether state-level execution can alter federal statutory requirements without invalidating the regulatory architecture.

7. Indus Waters Treaty Freeze: India Ramps Up J&K Hydropower

- **Strategic Shift in Water Diplomacy:** India has accelerated construction on three critical hydropower projects in Jammu and Kashmir, entailing an investment of \$3 billion. This reflects a major geopolitical shift after New Delhi placed the 1960 Indus Waters Treaty (IWT) in abeyance following a major cross-border terror attack in Pahalgam.
- **Massive Power Capacity Augmentation:** The three fast-tracked projects possess a combined capacity of 2.35 GW. The infrastructure pipeline includes phase two of state-run NHPC's Dulhasti project (260 MW) on the Chenab river in Kishtwar, the Uri-I Stage 2 project (240 MW) on the Jhelum river in Baramulla, and the mega Sawalkot project (1856 MW).
- **Inter-Basin Water Diversion Plan:** NHPC has initiated tenders for the ambitious Dahi Nallah diversion project on a tributary of the Chenab. This engineering initiative aims to divert water that previously flowed directly into Pakistan through a dedicated tunnel toward the operational Kishanganga project (330 MW), generating an additional 30 million units of electricity annually.

- **Unilateral Sediment Management:** Moving away from joint technical protocols, India will carry out routine monsoon silt-flushing at its J&K hydro reservoirs at least once a month. While maximizing the operational lifespan of Indian dams, this independent management may trigger temporary surges in sediment load and water volatility downstream in Pakistan.

- **Stringent Radio Directives:** Private FM radio operators are required to broadcast at least one hour of social relevance programming, ensure that a minimum of 20% of their daily content is locally produced, and remain strictly free-to-air without charging listeners for access.
- **Security and Governance Standards:** To protect national security interests, the appointments of all key managerial personnel in broadcasting entities require mandatory prior security clearance. Furthermore, any ownership switch leading to key management changes must obtain government approval in advance.
- **Key Definitions:** **Internet Protocol Television (IPTV)** refers to a system where television services are delivered using the internet protocol suite over a packet-switched network such as the internet, instead of being delivered through traditional terrestrial, satellite signal, or cable television formats. **Landing-Page Placement** is the practice where a TV channel is forced to appear as the default or first screen whenever a user turns on their set-top box, artificially inflating viewer ratings.

- **Ban on Allotting Animals as Symbols:** The ECI maintains a strict administrative stance against allotting living creatures or animals as new election symbols. This policy was instituted in the 1990s following intensive representations from animal welfare activists who demonstrated that tying live animals to fast-moving vehicles and using them in crowded political rallies led to widespread cruelty, injuries, and animal fatalities.
- **Exceptions and Legally Vested Rights:** The restriction on animal symbols applies strictly to new allocations and does not retroactively strip established parties of their historical identifiers. For instance, the Bahujan Samaj Party (BSP) retains the elephant as its

reserved national symbol because its allocation predates the enforcement of the modern animal ban.

- **Mechanism of the Free Symbols Pool:** The ECI revises its free symbols pool periodically, which consists of a diverse list of non-living items ranging from fruits and vegetables to household appliances and sports equipment. The pool contains approximately 184 generic symbols, allowing unrecognized political groups to request a preferred choice without a guarantee of exclusive allotment.

 - * **Free Symbol:** A standardized symbol from an ECI-approved list that is not explicitly reserved for any recognized national or state political party and is available for temporary allocation to independent or unrecognized candidates.

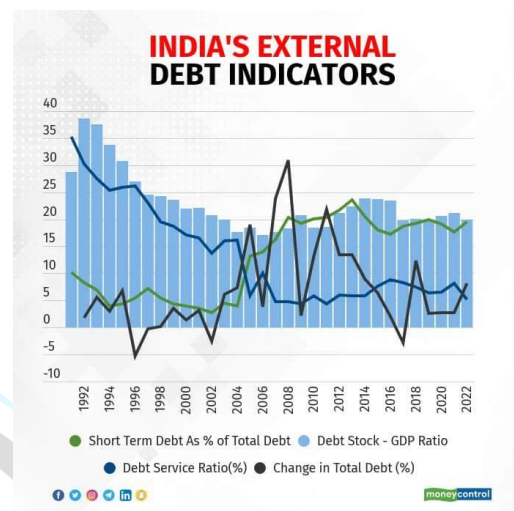

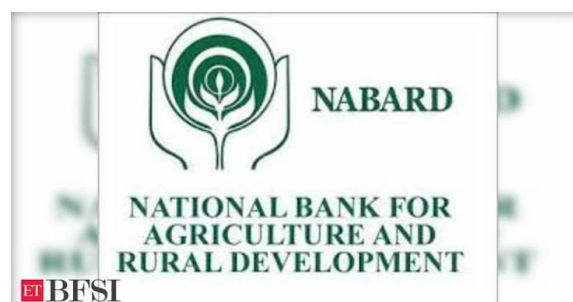

- **Shift in Participation:** Triggered by extreme spot market movements, the retail share of NSE currency futures rebounded sharply from 5.9% in March to 11.1% in May 2026, matching a parallel rise in Foreign Portfolio Investors (FPIs) to 17.3%.



- **Strict Compliance Standards:** To prevent speculation, brokerages require a Chartered Accountant (CA) certificate alongside supporting commercial invoices. Non-compliance risks severe statutory prosecution under India's foreign exchange laws.

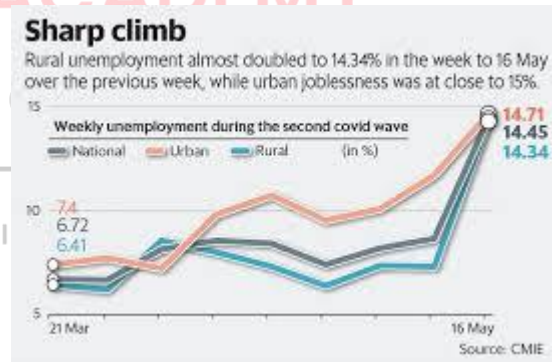

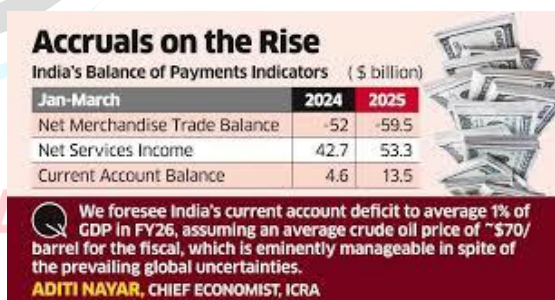

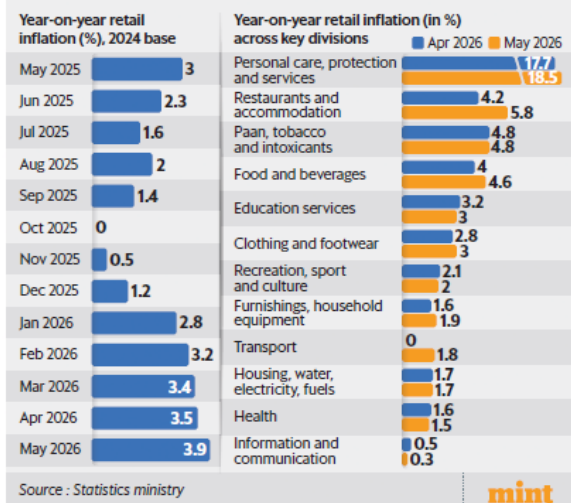

- **Key Definitions: Gig Economy** refers to a labor market characterized by the prevalence of short-term contracts or freelance work as opposed to permanent jobs. **Digital Platform Workers** are individuals who use digital applications or platforms to connect with clients, perform tasks, or provide services. **ILO Conventions** are international treaties that create legally binding obligations for ratifying member nations.

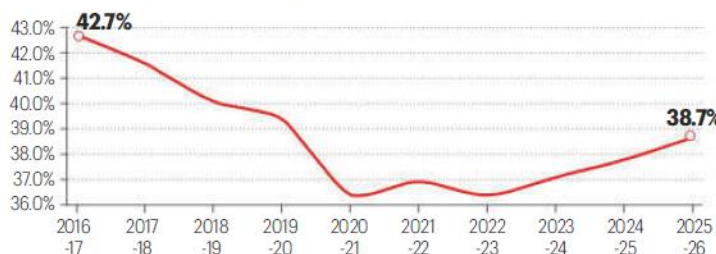

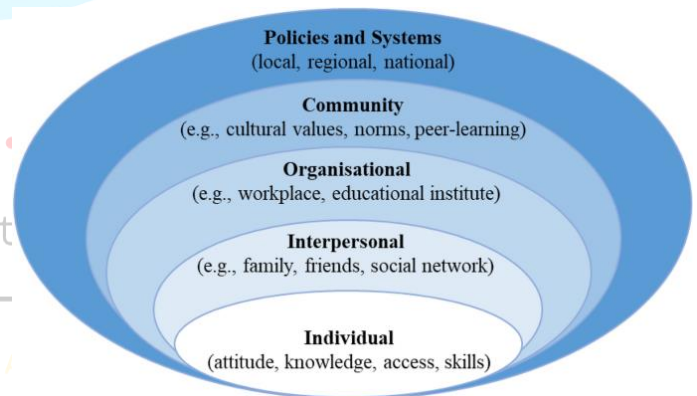

- **Expanding Retail Investment:** Urban India is witnessing a structural shift from a culture of high savings to active investing, with individuals holding a diversified mix of both physical and financial assets rising from 35% in 2022 to 45% in 2026.
- **Persistent Gender Divide:** Despite a shrinking pool of non-investors overall, a stark gender gap remains; nearly 28% of women do not invest at all compared to 19% of men, a divide most pronounced in tier-3 cities and among Gen Z cohorts.
- **Asset Allocation Divergence:** Investment preferences vary heavily by gender; men show a higher affinity for market-linked equities (34%), whereas women prefer safe-haven assets, heavily favoring gold jewelry and gold ETFs (26%).

- **Monsoon Dependency and Shock:** The South-West monsoon drives over 70% of India's annual rainfall, meaning erratic or below-normal precipitation forces an immediate structural shift toward groundwater extraction to sustain standing Kharif crops.
- **Energy Consumption Squeeze:** The farm sector consumes nearly 2/5 (40%) of India's annual diesel demand of 92 million tonnes and 1/5 (20%) of its total electricity consumption of 1,700 terawatt-hours, turning dry spells into massive energy demand shocks.
- **Fiscal Burden on Farmers:** Increased reliance on diesel-run pump sets and electricity-powered tube wells drastically escalates input costs per acre, squeezing net margins and accelerating agricultural debt cycles.
- **Grid and Utility Vulnerability:** The surge in power demand for irrigation places immense operational and financial stress on state power distribution companies (DISCOMs) due to subsidized farm electricity tariffs.
- **Regional Disparities:** Groundwater-dependent and heavily mechanized agricultural zones, specifically Punjab, Haryana, and Western Uttar Pradesh, face the highest risk of acute power shortages and soaring fuel bills.

- **Exceptional Growth Trajectory:** The volume of FDI over this recent 12-year window marks a 169% increase compared to the preceding 12-year period, reflecting sustained improvement in the ease of doing business.
- **Record-Breaking Resilience:** Despite persistent global macroeconomic headwinds, tightening monetary policies, and geopolitical uncertainties, India registered its highest-ever single-year FDI inflow of \$94.53 billion in the fiscal year 2025-26.
- **Institutional Drivers:** This investment surge is primarily propelled by proactive liberalizations implemented by the Department for Promotion of Industry and Internal Trade (DPIIT), including the expansion of automatic approval routes.

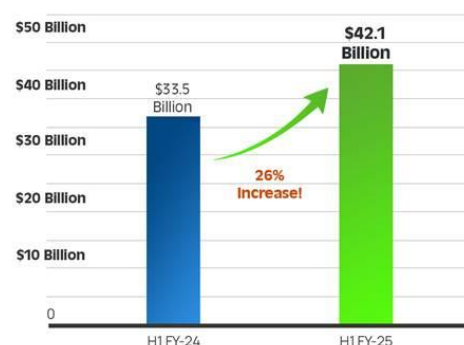

20. The Foreign Contribution (Regulation) Amendment Bill, 2026

- **Expansion of Executive Control:** The Foreign Contribution (Regulation) Amendment (FCRA) Bill, 2026, marks a structural shift from merely regulating external funding to enabling extensive state control over the assets and operations of civil society organizations, charitable trusts, and educational and religious institutions.
- **Mechanism of Asset Vesting:** Under the proposed Section 16A, when an organization's FCRA registration is cancelled, surrendered, or ceases, its foreign contributions and derived assets "provisionally vest" in a government-appointed Designated Authority without prior judicial review, with permanent sale proceeds credited to the Consolidated Fund of India.
- **Procedural Paralysis and Cessation:** The newly introduced Section 14B establishes automatic "cessation" of registration if an institution fails to apply for renewal on time or if the renewal remains pending, allowing bureaucratic and administrative delays to effectively freeze organizational functioning.
- **Centralization of Enforcement:** Amendments to Section 43 centralize investigative authority by requiring prior Union government approval before state agencies can probe FCRA violations, while a revised



Section 13 bars organizations from managing assets during suspension periods without explicit central clearance.

- **Socio-Economic and Sectoral Fallout:** Revocation of licenses threatens community welfare infrastructure, including child protection, healthcare, and education. Civil society accounts for substantial employment, and administrative closures directly impact livelihoods and essential services for vulnerable groups.

Key Definitions

- **Provisional Vesting:** The temporary administrative assumption of control, management, and custody of an organization's properties and financial assets by a state-designated authority pending a final statutory determination.
- **Consolidated Fund of India:** The primary repository of all government inflows, including taxes, loans, and revenues, established under Article 266(1) of the Constitution, into which permanent asset liquidation proceeds will be credited under the new bill.

21. Institutional Gaps in Reporting Industrial Accidents

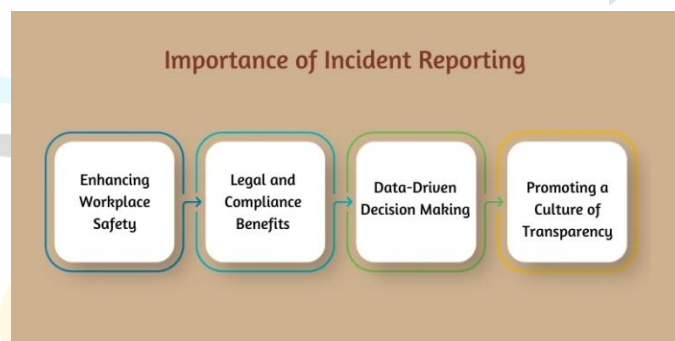
- **Recent Catalyst:** A major explosion at the Rashtriya Ispat Nigam Limited-Visakhapatnam Steel Plant (RINL-VSP) on June 8, 2026, resulted in nine fatalities, triggering standard reactive state protocols such as ex-gratia payments and high-level probe committees rather than proactive structural safety reforms.
- **Severe Statistical Divergence:** The annual Standard Reference Notes (SRNs) reveal massive inconsistencies between data compiled by the Labour Bureau and the Directorate

General Factory Advice Service and Labour Institutes (DGFASLI), indicating severe underreporting and coordination failure in workplace safety tracking.

- **Chronic Inspectorate Vacancies:** DGFASLI and state-level enforcement bodies are severely hampered by administrative shortages. Even highly industrialized provinces like Tamil Nadu lack sufficient factory inspectors to enforce basic safety compliance.
- **Low Inspection Rates:** Due to acute manpower deficits, only a small fraction of registered factories undergo safety inspections each year, creating a regulatory vacuum where hazardous operational violations go entirely undetected until a disaster occurs.
- **State-Level Reporting Lapses:** The federal data collection mechanism is broken, as multiple State governments consistently fail to submit required workplace accident details, thereby undermining national risk assessment frameworks.

Key Definitions & Legal Provisions

- **DGFASLI:** Directorate General Factory Advice Service and Labour Institutes; the technical arm of the Ministry of Labour and Employment that advises government, industry, and trade unions on matters relating to safety, health, and welfare of workers in factories.
- **OSH Code, 2020:** The Occupational Safety, Health and Working Conditions Code, 2020; a legislative code consolidating 13 central labour laws to reform workplace safety, which recently renamed DGFASLI as the Directorate General of Occupational Safety and Health.
- **Article 24 Union List Entry 55:** Governs regulation of labour and safety in mines and oilfields, while Entry 24 of the Concurrent List covers welfare of labour including conditions of work, giving both Centre and States jurisdiction.

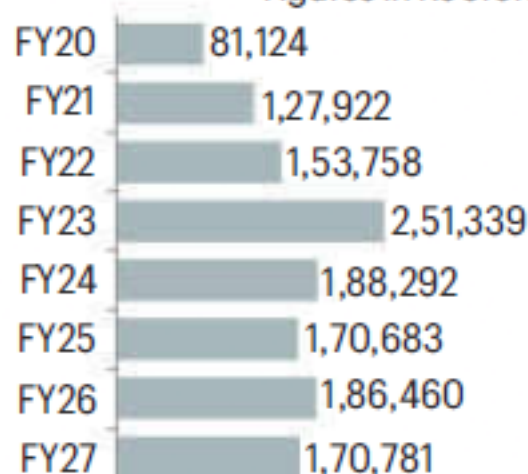
22. Global Supply Crunch Triggers Surge in India's Fertiliser Subsidy Burden

- **Subsidy Surge Amid Global Crisis:** India's fertiliser subsidy burden is projected to double to nearly **Rs 3.4 lakh crore** against the Budget Estimate (BE) of Rs 1.7 lakh crore. This fiscal strain is driven by skyrocketing global costs resulting from severe logistical disruptions, including a near-closure of the **Strait of Hormuz** due to regional conflict and subsequent naval blockades.

- **Supply Chain and Logistical Bottlenecks:** The West Asia crisis has triggered severe port congestion on India's western seaboard. Exporters face soaring freight costs, "opportunistic pricing" by foreign shipping lines, and non-transparent impositions of **demurrage and detention charges**, severely impacting trade margins.
- **Government Mitigation and Domestic Strategy:** To counter the international supply crunch and maintain affordable domestic prices, Public Sector Undertakings (PSUs) are floating import tenders. Simultaneously, the government plans to diversify import channels by tapping **Russia** while aggressively ramping up domestic fertiliser production.
- **Mechanism of Subsidy Disbursal:** Fertilisers are sold to farmers at subsidized, government-fixed Maximum Retail Prices (MRP). The Union Government bridges the gap between the higher cost of production/import and the lower market retail price by paying the difference directly to fertiliser manufacturers.
- **Key Economic and Legal Definitions:** *
Demurrage: Fine levied by a shipping line when cargo containers remain inside the port terminal beyond the allowed free time.
 - **Detention Charges:** Fee charged for holding empty containers outside the port terminal past the agreed duration.
 - **Nutrient Based Subsidy (NBS):** A scheme administered since 2010 where a fixed amount of subsidy is decided on an annual basis for each nutrient (N, P, K, S) present in non-urea fertilisers.

Constitutional and Legal Provisions

- **Article 112 (Annual Financial Statement):** The dramatic expansion of the subsidy from Rs 1.7 lakh crore to Rs 3.4 lakh crore requires parliament-approved supplementary demands for grants, highlighting fiscal deviation from the original budget estimates.
- **Essential Commodities Act, 1955:** Fertilisers are declared as essential commodities under this Act. The government utilizes the **Fertiliser Control Order (FCO), 1985** to regulate the price, distribution, and quality of fertilisers across the country.
- **Article 39(b) of Directive Principles (DPSP):** Directs state policy toward ensuring that ownership and control of material resources are distributed to best subserve the common good, justifying massive agricultural subsidies to secure food production.

Conclusion and UPSC Relevance

The escalating subsidy bill underscores India's vulnerability to global geopolitical choke points and volatile commodity markets. Balancing the fiscal deficit target while shielding domestic agriculture remains a critical macroeconomic challenge.

23. Primacy of Statutory Law: IBC Provisions Overrule Supreme Court Rules, Affirms SC

- **Primacy of Parliamentary Statute over Procedural Rules:** The Supreme Court (SC) ruled that in case of any direct conflict between the provisions of the Insolvency and Bankruptcy Code (IBC) and the Supreme Court Rules (SCR), the IBC will prevail. A bench of Justices Dipankar Datta and Satish Chandra Sharma clarified that the SCR is a form of subordinate legislation and cannot undermine or dilute the strict statutory timelines mandated by Parliament.
- **IBC as a Self-Contained Legal Framework:** The apex court re-emphasized that the IBC is a "complete code in itself." Consequently, litigants cannot bypass or subvert the strict limitation regime governing insolvency appeals by deliberately filing defective applications to manipulate timelines and later attempting to cure those defects at their own convenience.
- **Defective Appeals and the Extinguishment of Rights:** The court established that under Section 62 of the IBC, an appeal must be filed in a defect-free, proper format to be recognized as legally instituted. Once the core statutory period of 45 days for filing an appeal, along with the conditional 15-day condonable extension, is exhausted, any subsequent right to appeal stands permanently extinguished, overriding the more flexible re-filing timelines found under standard civil or criminal procedural rules.
- **Refusal to Invoke Extraordinary Constitutional Powers:** The bench declined to invoke its extraordinary jurisdiction under Article 142 of the Constitution to condone delays, despite the appellant being a court-appointed liquidator acting in the interest of stakeholders. The court held that judicial officers cannot be granted preferential relaxation unless explicitly provided by Parliament within the statute itself.
- **Key Economic and Legal Definitions:**
 - *** Complete Code in Itself:** A legal term for a comprehensive statute that exhaustively governs a specific subject matter, intentionally excluding the application of general procedural or limitation laws.
 - **Condonation of Delay:** A discretionary judicial power allowing courts to overlook a litigant's failure to adhere to statutory timelines if a legally sufficient and bona fide cause for the delay is established.
 - **Subordinate Legislation:** Rules, regulations, or bylaws framed by an executive body, judiciary, or administrative authority under the powers delegated to them by a primary parliamentary act.



Constitutional and Legal Provisions

- **Article 142 of the Constitution:** Grants the Supreme Court the extraordinary power to pass any decree or order necessary for doing "complete justice" in any cause or matter pending before it. This ruling confirms that Article 142 cannot be used to subvert express statutory mandates.

- **Section 62 of the Insolvency and Bankruptcy Code, 2016:** Governs the statutory procedure for filing an appeal directly to the Supreme Court from an order passed by the National Company Law Appellate Tribunal (NCLAT), stipulating rigid, non-negotiable timelines.
- **Article 145 of the Constitution:** Empowers the Supreme Court, with the approval of the President, to make rules for regulating the general practice and procedure of the court (the statutory basis for the Supreme Court Rules).

Conclusion and UPSC Relevance

This landmark judgment secures the core economic legislative intent of the IBC—ensuring time-bound resolution and preservation of asset values—by blocking procedural loopholes. It reinforces the constitutional principle that delegated legislation must yield to parent parliamentary statutes.

1. Delayed Monsoon and Summer Crop Sowing: Threats to Agricultural Output

Key Summary Points

- **Sowing Deficit:** Indian farmers have fallen behind the traditional sowing schedule for major summer (Kharif) crops, including rice, cotton, corn, and soybeans, due to a sluggish, delayed onset of the southwest monsoon.
- **Monsoon Dependency:** The annual monsoon rains, which typically arrive in June and July, provide over 70% of the precipitation required for Indian agriculture, making timely onset critical for unirrigated tracts.
- **Global Rice Markets:** As India is the world's largest rice exporter, accounting for nearly 40% of global grain shipments, any significant reduction in domestic Kharif rice output threatens international food security and price stability.
- **Acreage Lag:** The slow progress of rain has led to below-average cumulative rainfall across key agricultural states, directly translating into lower initial acreage figures for moisture-sensitive oilseeds and pulses.
- **Inflationary Pressures:** Delayed sowing compresses the crop growth cycle, potentially depressing final yields and sparking domestic food inflation, which poses a direct challenge to macroeconomic stability and rural demand.

Key Concepts & Constitutional Provisions

- **Kharif Crops:** Summer agricultural crops sown with the onset of the southwest monsoon (June-July) and harvested in autumn (September-October), requiring high temperatures and substantial moisture.
- **Southwest Monsoon:** A seasonal wind pattern blowing from sea to land between June and September, serving as the lifeblood of India's agrarian economy and rural groundwater recharge.
- **Article 39(b) & (c):** Directives ensuring that the ownership and control of material resources are distributed to subserve the common good, mandating state intervention to secure food availability.

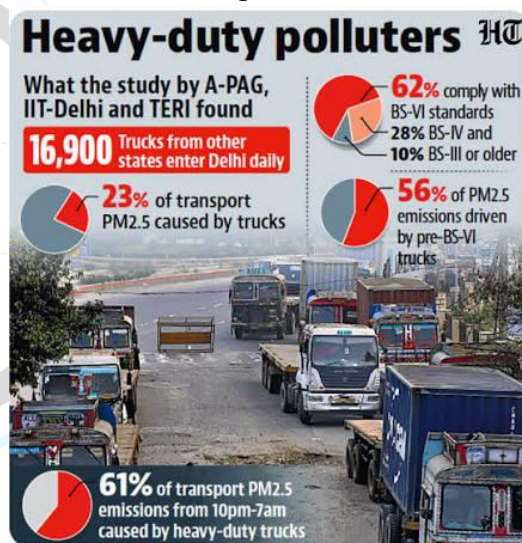

2. Heavy-Duty Vehicles and Urban Air Pollution: The PM2.5 Challenge

Key Summary Points

- **Disproportionate Emissions:** A study by the Ministry of Road Transport and Highways (MoRTH) reveals that heavy-duty trucks and buses comprise just 2.5-3% of India's total vehicle fleet but contribute a massive 35-36% of transport-related fine particulate matter (PM2.5) emissions.
- **The Diesel Factor:** The high emission footprint of these 7.36 million registered commercial vehicles stems from large engine displacements, heavy payload capacities, long continuous operating hours, and a high reliance on diesel fuel.
- **Public Health Risk:** While transport emissions include carbon monoxide, hydrocarbons, and nitrogen oxides, experts identify PM2.5 as the most hazardous pollutant due to its ability to penetrate deep into human lungs and the bloodstream.
- **Policy Catalyst:** These findings strongly reinforce the government's push for a faster transition to the proposed Bharat Stage VII (BS VII) emission framework and accelerated commercial fleet modernization.
- **Scrappage and Modernization:** The high pollution share highlights the critical need to aggressively enforce the Voluntary Vehicle-Fleet Modernization Policy (Vehicle Scrappage Policy) to phase out older, polluting heavy commercial vehicles.



Key Concepts & Constitutional Provisions

- **Fine Particulate Matter (PM2.5):** Airborne particles with an aerodynamic diameter of less than 2.5 micrometers that remain suspended for long periods and cause severe respiratory and cardiovascular diseases.
- **BS VII Emission Norms:** The upcoming, highly stringent institutional standards aimed at drastically lowering permissible limits for tailpipe emissions, particularly targeting particulate matter and nitrogen oxides in heavy commercial vehicles.
- **Article 21:** The Right to Life implicitly includes the right to breathe clean, unpolluted air and live in a healthy environment, as affirmed repeatedly by the Supreme Court of India.
- **Article 48A (DPSP):** Directs the State to protect and improve the environment, providing the constitutional foundation for vehicle emission regulations.
- **Legal Framework:** Regulated primarily under the Air (Prevention and Control of Pollution) Act, 1981, and the Central Motor Vehicles Rules, 1989, enacted under the Motor Vehicles Act, 1988.

Conclusion

Addressing the heavy-duty vehicle sector is essential for improving urban air quality. Implementing BS VII norms and introducing targeted fiscal incentives for electric or LNG-powered heavy trucks will allow India to reduce transport pollution without slowing down logistical and economic growth.

3. Reconstitution of Aravallis Panel: Demands for Critical Ecological Zone

- **Core Issue:** The Aravalli Virasat Jan Abhiyaan (AVJA), an environmental coalition, has petitioned the Chief Justice of India (CJI) seeking the immediate reconstitution of a Supreme Court-appointed committee tasked with defining and managing the 700-km Aravalli mountain range.
- **Institutional Conflict:** Activists demand that neither the Chairperson nor the Member Secretary of the panel should be serving officers of the Ministry of Environment, Forest and Climate Change (MoEF&CC), arguing that independent ecologists, environmentalists, or scientists free from ministry control are vital to ensure unbiased domain expertise.
- **Definition Dispute:** The representation, submitted on the eve of the World Day to Combat Desertification and Drought, strongly opposes the "regressive" uniform definition of the Aravallis accepted by the Supreme Court in its November 20, 2025 order and demands it be scrapped.
- **Ecological Protection:** The group has urged the judiciary to officially declare the remnants of the Aravalli range as a 'Critical Ecological Zone' to safeguard it from rampant mining, urbanization, and rapid degradation.
- **Key Concept Definitions: Critical Ecological Zone (CEZ)** refers to a geographically vulnerable area requiring stringent legal protections against developmental activities due to its role in maintaining biodiversity and environmental stability. The Aravallis act as a critical ecological barrier protecting northwest India from desertification.
- **Constitutional & Legal Provisions:** Under **Article 48A** (Directive Principles), the State is mandated to protect and improve the environment. **Article 51A(g)** imposes a Fundamental Duty on citizens to protect natural environments. Furthermore, the **Environment (Protection) Act, 1986** gives the central government the statutory power to declare ecologically sensitive areas and restrict industrial operations to protect fragile eco-systems like the Aravallis.



Conclusion

The demand for institutional independence in environmental committees highlights the need for ecological governance to be free from executive conflict of interest. Protecting the Aravallis

requires an objective, science-based approach that balances regulatory enforcement with active conservation to prevent micro-climate degradation and desert expansion in northern India.

4. Strong El Niño and Its Implication on India

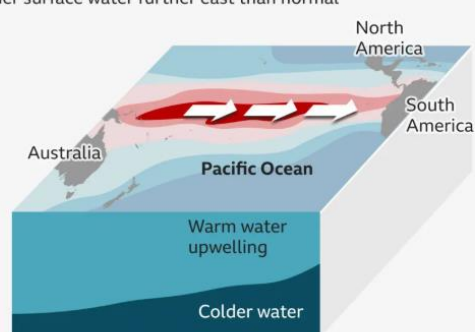
Key Definitions: * **El Niño:** A climate pattern involving the abnormal warming of surface waters in the equatorial Pacific Ocean, disrupting global atmospheric circulation.

- **Long-Period Average (LPA):** The benchmark rainfall calculated over a 50-year period (currently 82.8 cm for the southwest monsoon).

Core Summary & UPSC Key Points

- **The Forecast:** NOAA confirmed the emergence of a "very strong" El Niño, with a 63% probability of sea surface temperatures exceeding 2Degree above normal. It is expected to peak around November–December and persist into early 2027.
- **Monsoon Impact:** Historically, 12 out of 17 El Niño years since 1951 led to deficient or below-normal rainfall. Current projections estimate rainfall at 90% of the LPA, potentially making it the weakest monsoon since 2015.
- **Agricultural Vulnerability:** Delayed monsoon arrival and escalating rainfall deficits threaten the sowing of Kharif crops. While public rice stocks provide a buffer, rain-fed pulses, oilseeds, vegetables, and dairy production face severe risks from prolonged dry spells and pest infestations.
- **Macroeconomic and Sectoral Strain:** Beyond agriculture, a weak monsoon compromises groundwater recharge, reservoir replenishment, and hydropower generation. This supply-side disruption threatens to exacerbate retail food inflation, which climbed to 4.8% in May.
- **The IOD Factor:** A positive Indian Ocean Dipole (IOD)—warmer western Indian Ocean waters—can counter El Niño's impact. However, the IMD projects neutral IOD conditions, diminishing hopes for natural mitigation.

It provides 240-degree coverage via an Active Electronically Scanned Array (AESA) radar, offering state-of-the-art capabilities in airborne surveillance, low-flying cruise missile tracking, threat assessment, and real-time battle management.
- **Proven Operational Combat Reliability:** Prior to obtaining its formal FOC, Netra demonstrated exceptional tactical utility and reliability during critical high-stakes operations. It played a central role in conducting network-centric command-and-control during the 2019 Balakot air strikes and the cross-border engagements of Operation Sindoor in 2025.

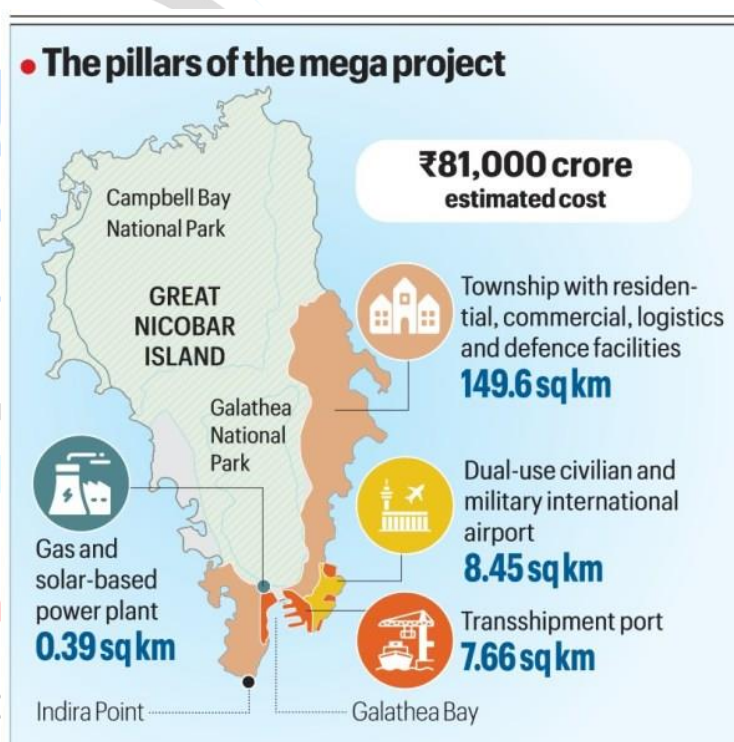

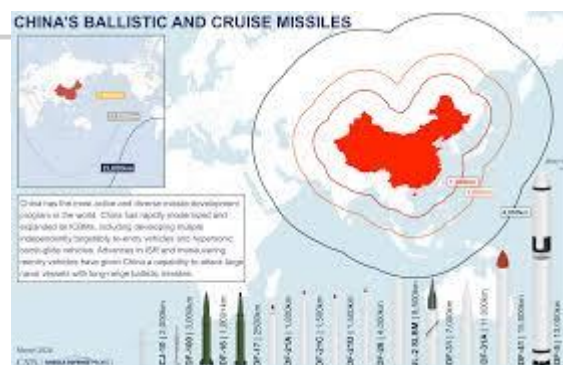

- **Global Combat Precedent:** Developed by the United States, HIMARS has emerged as a cornerstone strike system in contemporary asymmetric warfare, heavily utilized by Ukrainian forces to disrupt logistics, command nodes, and heavily fortified Russian military positions.
- **Cross-Strait Geopolitics & Legal Frameworks:** The arms transfer aligns with the United States' domestic legislation under the Taiwan Relations Act (TRA) of 1979, which mandates Washington to provide Taipei with defensive arms necessary to maintain a sufficient self-defense capability, contrasting sharply with Beijing's "One China" principle.

- **Sub-Zero Logistics and Hydrological Hazards:** Construction teams faced extreme conditions with winter temperatures plunging to -30°C , inducing mechanical failure and avalanche hazards. Additionally, melting snow and massive internal water ingress required the installation of specialized drainage pipes to relieve internal mountain pressure and avoid structural collapses.
- **Advanced Engineering Methodology:** To navigate this fragile topography safely, engineers deployed the New Austrian Tunnelling Method (NATM). This approach utilizes controlled, sequential blasting, immediate structural reinforcement using shotcrete and rock bolts, and continuous geotechnical monitoring to flexibly adapt to varying rock integrity.

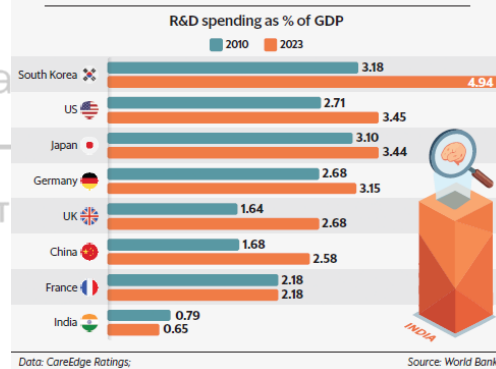

India's chief economic adviser V. Anantha Nageswaran recently flagged low investment in research and development. Data shows India spends less than 1% of GDP on R&D, lagging key nations.

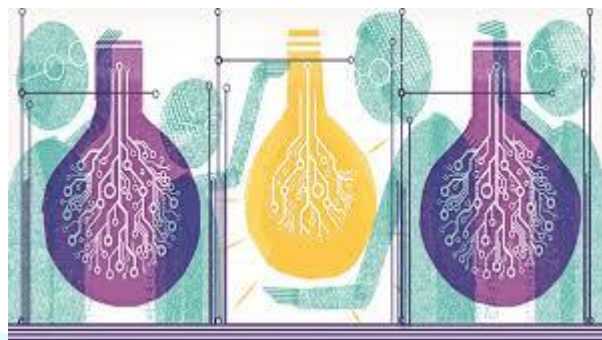

- **Fear-Based Choice Architecture:** The CCPA found that McAfee utilized a deceptive subscription renewal interface. By presenting binary options like "Renew Now" and "Accept Risk," the platform created psychological pressure and simulated security threats to distort neutral consumer decision-making.
- **Mandate for Affirmative Consent:** The regulatory body established that consumer consent must be explicit, active, and unambiguous. Digital interfaces cannot assume consent through pre-ticked checkboxes or asymmetric visual hierarchies that favor corporate transactions over user autonomy.
- **Systemic Regulatory Crackdown:** This enforcement action follows the 2023 Dark Patterns Guidelines and a subsequent 2025 self-audit advisory. It marks a transition from purely advisory frameworks to active penal deterrence within India's expanding digital marketplace.

Constitutional and Legal Framework

Migrant households (17.61%), local youth (16.73%), senior citizens (15.80%), and women (13.40%) constitute the least represented cohorts, revealing that baseline attendance does not automatically guarantee inclusive or equitable platform access.
- **Conceptual Shift to Institutional Responsiveness:** Reframing how grassroots democracy is measured, NITI Aayog and the Ministry emphasized that Gram Sabha performance must shift from mere attendance metrics to deep institutional responsiveness. The study introduces a solution-oriented framework focused on translating local civic inputs into verifiable action and systemic accountability.

This massive agrarian and political uprising targeted British colonial authorities and predatory "dikus" (non-tribal outsider landlords/moneylenders) who were aggressively encroaching upon traditional tribal lands and socio-cultural institutions.
- **Battle of Dombari Buru:** The rebellion reached its tragic climax in January 1899 at Dombari Buru hill in Khunti, where British forces surrounded and opened fire on thousands of Munda followers. Although the uprising was suppressed and Birsa Munda died in Ranchi Jail on June 9, 1900, Dombari Buru permanently endured as an iconic symbol of Adivasi structural resistance.
- **Legislative Aftermath:** The immense pressure generated by the Ulgulan forced the British administration to initiate critical land reforms. This culminated in the enactment of the Chotanagpur Tenancy (CNT) Act in 1908, which legally recognized traditional land tenure systems and strictly prohibited the transfer of tribal lands to non-tribals.
- **Socio-Religious Synthesis:** Revering him as "Dharti Aba" (Father of the Earth), his followers founded the "Birsait" faith. This unique movement blended elements of traditional tribal Sarnaism, Hinduism (Vaishnavism), and critique of Christian missionary exploitation, emphasizing that true Adivasi identity is rooted deeply in community, nature, and ancestral land heritage rather than institutional religion.

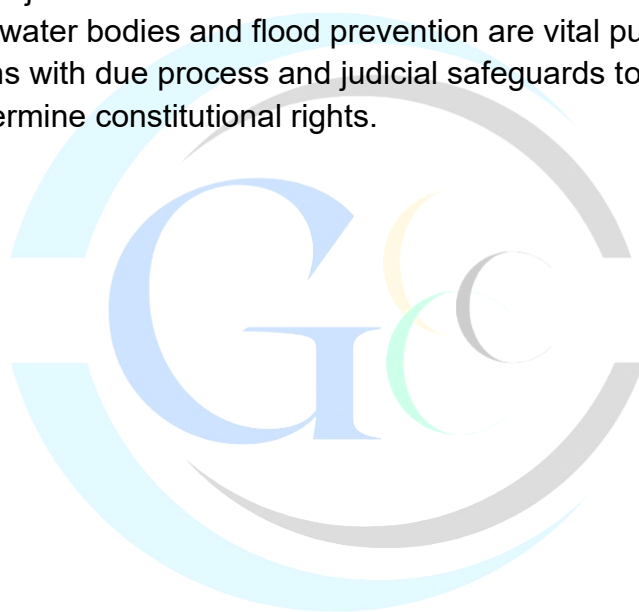

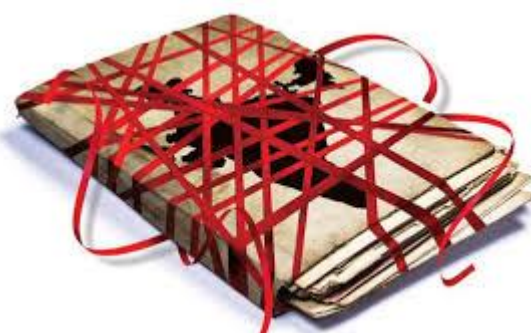

- **Delayed Vigilance Action:** The Rajasthan Forest Department has delayed initiating an Anti-Corruption Bureau (ACB) probe for over 15 months, despite an internal enquiry report explicitly exposing systemic embezzlement in state-funded plantation works.
- **Modus Operandi of Financial Fraud:** The initial 2025 investigation uncovered extensive administrative irregularities, including the production of forged bills, fabricated plantation field records, fake signatures, and illicit institutional money transfers.
- **Siphoning of Public Funds:** The core of the financial graft involves an illegal withdrawal of ₹17 crore earmarked for advance soil conservation and moisture work during 2023-24 across a single forest range located within the Alwar division.
- **Dilution via Bureaucratic Delays:** Accountability mechanisms are being diluted through successive oversight loops. A secondary administrative report attempted to downplay the fraud by arguing that transactions occurred via bank transfers rather than cash, stalling the final ACB referral.

Furthermore, up to 72.3% of treated patients achieved at least a 5% reduction in overall body weight, presenting a dose-dependent, clinically meaningful therapy for both diabetic and non-diabetic obese populations.
- Relevance to the Indian "Thin-Fat" Phenotype:** India is home to over 100 million diabetic individuals who frequently develop Type 2 Diabetes Mellitus (T2DM) at lower Body Mass Index (BMI) thresholds than Western cohorts. This is driven by the unique South Asian "thin-fat" phenotype—characterized by higher visceral fat, lower muscle mass, and severe insulin resistance despite a relatively lean external appearance—making concurrent blood sugar and visceral fat regulation critical.
- Patient Compliance and Structural Advantages:** Unlike early-generation oral semaglutide formulations that require strict, empty-stomach administration with water restrictions, elecoglipron can be taken without food or fluid limitations. This flexibility eliminates major behavioral adherence barriers, though mild-to-moderate gastrointestinal side effects (nausea, vomiting, altered bowel habits) remain consistent with the GLP-1 drug class.
- Key Scientific Definitions:**
 - * GLP-1 (Glucagon-Like Peptide-1):** An incretin gut hormone that stimulates glucose-dependent insulin secretion, inhibits glucagon release, delays gastric emptying, and induces central satiety to regulate appetite.
 - HbA1c (Glycated Haemoglobin):** A key diagnostic biomarker that measures the average percentage of blood glucose bound to hemoglobin over the preceding 2 to 3 months.



- **Phase 3 Clinical Trials:** Large-scale multicenter trials on expanded patient populations designed to definitively confirm safety, tolerability, optimal efficacy, and preservation of lean muscle mass before structural regulatory approval.

Constitutional and Legal Provisions

- **Article 47 (Directive Principles of State Policy):** Obligates the State to regard the raising of the level of nutrition, the standard of living, and the improvement of public health as among its primary duties, driving policies against non-communicable disease (NCD) epidemics.

- **Drugs and Cosmetics Act, 1940:** Regulates the import, manufacture, and distribution of drugs in India. Any breakthrough molecule like elecoglipron must clear rigorous clinical data reviews by the **Central Drugs Standard Control Organisation (CDSCO)** before local market commercialization.

Conclusion

The development of flexible, non-invasive oral GLP-1 therapies holds transformative potential to mitigate India's escalating public health burden from metabolic syndromes.

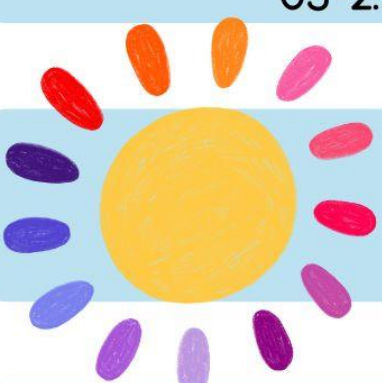
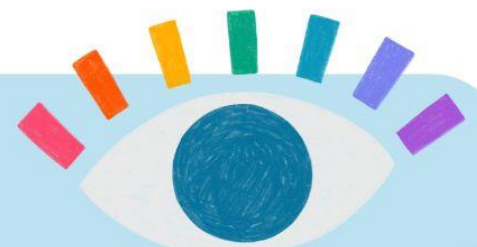
